FUND THE NEED: BEREAVEMENT CARE SERVICES

Bereavement Care through Montgomery & Prince George’s Hospice is available without charge to any individual in Montgomery or Prince George’s counties who has experienced the death of a family member, friend, or colleague.

- Our professional grief counselors use a variety of approaches that fit individuals’ values, beliefs, and culture.
- They offer caring support to bereaved persons, helping them understand their feelings and adjust to their loss by providing information through, telephone counseling, support groups, and workshops.
- Loved ones of adult patients receive 13 months of support following the loss.
- Families of our pediatric patients receive support during the course of the child’s care and up to two years following the loss.

Medicare requires hospices to provide grief and loss support to patients’ families but does not offer compensation for this critically important service. The minimum annual cost to provide this meaningful care and support is \$700,000.

Your support of the 2026 Gala will help us to continue to provide our free grief and loss services to our grieving community members.

Thank you in advance for helping us to gentle the journey for our neighbors, friends, and colleagues. Together, we will continue to make a difference in the lives of many during a very tender time.
